2. HAZARDS IDENTIFICATION	
2.1 Classification of the substance or mixture EC Classification: Not classified as dangerous under EC criteria.	
Health Hazards: Not expected to be a health hazard when used under normal conditions. Prolonged or repeated skin contact without proper cleaning can clog the pores of the skin resulting in disorders such as oil acne/folliculitis. High-pressure injection under the skin may cause serious damage including local necrosis. Used oil may contain harmful impurities.	
Signs and Symptoms:	Local necrosis is evidenced by delayed onset of pain and tissue damage a few hours following injection. Oil acne/folliculitis signs and symptoms may include formation of black pustules and spots on the skin of exposed areas. Ingestion may result in nausea, vomiting and/or diarrhoea.
Safety Hazards:	Not classified as flammable but will burn.
Environmental Hazards:	Not classified as dangerous for the environment.
3. COMPOSITION/INFORMATION ON INGREDIENTS	
3.1 Substance	
Preparation description:	Highly refined mineral oil.
Additional Information:	The highly refined mineral oil contains <3% (w7w) DMSO-extract, according to IP346.
4. FIRST-AID-MEASURES	
4.1 Description of first aid measures	
General Information: Not expected to be a health hazard when used under normal conditions.	
Inhalation:	No treatment necessary under normal conditions of use. If symptoms persist, obtain medical advice.
Skin Contact:	Remove contaminated clothing. Flush exposed area with water and follow by washing with soap if available. If persistent irritation occurs, obtain medical attention. When using high pressure equipment, injection of product under the skin can occur. If high pressure injuries occur, the casualty should be sent immediately to a hospital. Do not wait for symptoms to develop. Obtain medical attention even in the absence of apparent wounds.
Eye Contact:	Flush eye with copious quantities of water. If persistent irritation occurs, obtain medical attention.

4. FIRST-AID-MEASURES (Cont.)	
4.1 Description of first aid measures (Cont.)	
Ingestion:	In general no treatment is necessary unless large quantities are swallowed, however, get medical advice.
Advice to Physician:	Treat symptomatically. High pressure injection injuries require prompt surgical intervention and possibly steroid therapy, to minimise tissue damage and loss of function. Because entry wounds are small and do not reflect the seriousness of the underlying damage, surgical exploration to determine the extent of involvement may be necessary. Local anaesthetics or hot soaks should be avoided because they can contribute to swelling, vasospasm and ischaemia. Prompt surgical decompression, debridement and evacuation of foreign material should be performed under general anaesthetics, and wide exploration is essential.
5. FIRE FIGHTING MEASURES	
Clear fire area of all non-emergency personnel.	
5.1 Specific Hazards	
Hazardous combustion products may include: A complex mixture of airborne solid and liquid particulates and gases (smoke). Carbon monoxide. Unidentified organic and inorganic compounds.

Suitable Extinguishing media:	Foam, water spray or fog. Dry chemical powder, carbon dioxide, sand or earth may be used for small fires only.

7.2 Handling

Avoid prolonged or repeated contact with skin. Avoid inhaling vapour and/or mists. When handling product in drums, safety footwear should be worn and proper handling equipment should be used.

7.3 Storage

Keep container tightly closed and in a cool, well-ventilated place. Use properly labelled and closeable containers. Storage Temperature: 0 -50°C / 32 -122°F

Recommended Materials: For containers or container linings use mild steel.
 Unsuitable Materials: For containers or container linings avoid PVC, polyethylene or high density polyethylene.

8.2 Exposure controls

11. TOXICOLOGICAL INFORMATION

11.1 Information on toxicological effects

Basis for Assessment:	Information given is based on data on the components and the toxicology of similar products.
Acute Oral Toxicity:	Expected to be of low toxicity: LD50 >5000mg/kg, Rat
Acute Dermal Toxicity:	Expected to be of low toxicity: LD50 >5000mg/kg, Rabbit
Acute Inhalation Toxicity:	Not considered to be an inhalation hazard under normal conditions of use.
Skin Irritation:	Expected to be slightly irritating. Prolonged or repeated skin contact without proper cleaning can clog the pores of the skin resulting in disorders such as oil acne/folliculitis.
Eye Irritation:	Expected to be slightly irritating.

Reproductive and Developmental Toxicity:	Not expected to be a hazard.

11.2 Additional Information

Used oils may contain harmful impurities that have accumulated during use. The concentration of such impurities will depend on use and they may present risks to health and the environment on disposal. ALL used oil should be handled with caution and skin contact avoided as far as possible. High pressure injection of product into the skin may lead to local necrosis if the product is not surgically removed.

12. ECOLOGICAL INFORMATION

Ecotoxicological data have not been determined specifically for this product. Information given is based on knowledge of the components and the ecotoxicology of similar products.

12.1 Acute Toxicity

Poorly soluble mixture. May cause physical fouling of aquatic organisms. Expected to be practically nontoxic: LL/EL/IL50 >100mg/l (to aquatic organisms) (LL/EL50 expressed as the nominal amount of product required to prepare aqueous test extract). Mineral oil is not expected to cause any chronic effects to aquatic organisms at concentrations less than 1 mg/l.

12.2 Mobility

Liquid under most environmental conditions. Floats on water. If it enters soil, it adsorbs to soil particles and will not be mobile.

12.3 Persistence/degradability

Expected to be not readily biodegradable. Major constituents are expected to be inherently biodegradable, but the product contains components that may persist in the environment.
